#### Horses will be drug tested in 2023

- Overnight Entry Fee - \$30 - Doc Schoonover Trot & HCAS Pace Entry Fee - \$100
- Horses racing on Lasix must be reported at time of entry. Lasix will be the responsibility of the trainer.
- Colts stakes to be raced under rules of the Ohio Fair Funds Law, conditions of OCRA Circuit. Track will score 6 wide. One heat plan. Races may be split at speed committee's discretion to fill race card.
- Six (6) to enter and five (5) to start with position money only. Money divided: 50 – 25 – 12 – 8 – 5 percent. Right reserved to reject any entry. All participants must be licensed by the Ohio State Racing Commission. Anyone under suspension will not be allowed to participate at any level.
- The Hancock County Agricultural Society will not be liable for any damages that may occur due to accidents, fire, theft or any other causes.
- We will honor ORCA Stake passes by holders only. All others will be required to pay gate admission.
- All stalls must be vacated at the conclusion of the race program except those who have leased stalls.
