

work would require hired labor to complete. The directors may be paid their expenses at conventions and district meetings. The employees may receive special compensation for special services as agreed to by the Board of Directors.

Article VIII-Employees

Section 1. A caretaker may be hired by the Board of Directors and shall work as directed by the Board. A job description shall be on file at the Fair Office.

Section 2. A Junior Fair Coordinator may be hired by the Board of Directors and shall work as directed by the Board. A job description shall be on file at the Fair Office.

Section 3. A Fair Manager may be hired by the Board of Directors and shall work as directed by the Board. A job description shall be on file at the Fair Office.

Section 4. Other individuals may be hired as deemed necessary by the Board of Directors and shall work as directed by the Board. A job description shall be on file at the Fair Office.

Article IX-Membership

Section 1. (2022) All past board members that served three (3) terms or nine (9) years shall be considered a Life Member of the Society and be allowed a free season ticket and making open class entries at the Hancock County Fair. They shall receive a Life Membership certificate for the member and spouse to the Hancock County Agricultural Society. A Life Membership does not provide for voting rights unless the Life Member purchases a current year Membership Certificate to the Society.

Article X-General Rules

Section 1. A premium list must be published before the date of the fair and must include the rules and regulations governing the exhibitors.

Section 2. Superintendents of the various departments shall secure a competent judge for the department of which they are in charge.

Section 3. The Hancock County Agricultural Society being organized under Sec. 1711.01 of the general code, it shall be the duty of the executive committee to request the County Commissioners to include in their budget such appropriations as specified in Sec. 1771.01, 1711.03, 1711.15, and 1711.22.

Section 4. The Hancock County Agricultural Society shall have their annual fair or any other exhibition sponsored by or under the control of the agricultural society, an official veterinarian/s who has been approved by the Department of Agriculture of Ohio. Before the appointment of an official veterinarian/s the agricultural society shall submit to the Director of Agriculture, for his approval, the name/s and address/s of the veterinarian/s whom the agricultural society proposes to appoint. After the veterinarian/s recommended for appointment has been approved by the Director of Agriculture, the agricultural society shall certify his appointment to the Director of Agriculture not less than ten (10) days before the opening of the fair.
