#### Section 2.

Candidates must have completed a minimum of one year participation in the species specific to this application.

## Section 3.

Princess Candidates must be 12 to 14 years old as of January 1, of the current year to be eligible.

## Section 4.

Princess Candidates may serve a maximum of 2 one-year terms (2 years total). Must re-apply and interview each year.

## Section 5.

Department Royalty Candidates must have participated in the previous year's Hancock County 4-H Livestock Interview or the Hancock County 4-H Make Up Livestock Interview.

## Section 6.

If crowned you must attend the following events:

Hancock County Sheep Banquet

• ALL Open Class **AND** Jr. Fair Sheep shows at the Hancock County Fair Including Guys and Gals Lead and Showman of Showman competitions

- · Livestock Sale when your species are being sold
- Sheep Dept. Weigh-Ins
- Any other livestock specific event throughout the year (see below)

In addition to the previously mentioned duties in Section 6, the Lamb & Wool Princess will also:

• Assist with the Lamb Stand by working a shifts and soliciting others to work

• Participate in other fund-raising events or sheep exhibitions in support of Hancock County Sheep Improvement Association

- Collect donations to support the Guys & Gals Lead competition at the fair.
- Assist Lamb and Wool Queen in creating an education display for the Legacy Building to engage fairgoers
- Crown her successor at the banquet the following year.
- Maintain positive attitude and represent Hancock County Sheep Association in a positive manner

Candidates must participate in the interview process to be considered. Interviews will be held the day of the banquet. Applicants will be notified of the exact time and location for the interviews via email. The Hancock County Lamb & Wool Princess will be announced at the banquet sponsored by the Hancock County Sheep Improvement Association. The date for the banquet is **March 17, 2024** at Old Millstream Centre with interviews starting at 4:00 pm.

Selection of Lamb & Wool Queen will be based on the following:

- Written Essays -35 points
- Sheep Showing Experience -25 points
- Involvement (4-H/FFA, school, church, and community) -20 points
- Poise & Personality (Interview) -20 points
