- 2. Online entries at www.ustrotting.com are encourage.
- 3. Rain Dates in case of rainouts, Wednesday's card would race at 11:00 A.M. on Thursday, the 29<sup>th</sup> and Thursday's card would race at 11:00 A.M. on Friday the 30<sup>th</sup>
- 4. Lasix Veterinarian on the grounds.
- 5. Current negative Coggins test is required.
- 6.OSRC and USTA Rules to govern with exceptions. Rules of OCRA to govern Stake Races.
- 7. Events 5 & 11- Limited to eight (8) entries. (The race secretary may limit trainers to only one (1) entry). If more than eight (8) horses are entered, preferences will be as follows: (1) Ohio Sired (2) Wholly Ohio owned (3) Top money winners in 2024.
- 8. Track scores five (5) wide, six (6) to enter, five (5) to start.
- 9. Entry Fees:
- \$100 per horse for OCRA Stace Races
- \$100 per horse for Signature Series events
- \$30 per horse for overnight events
- 10. Purse Distribution: 50%-25%-12%-8%-5%.
- 11. Hancock County FAir is not responsible for accidents on or off the track.
- 12. Hancock County Fair reserves the right to postpone, declare off, change the program or refuse any entry.
- 13. Buckeye Consortium passes honored at the gate on racing days only.
- 14. On- Track accident Insurance policy in effect.
